The concerned DISCOMs and RESCOs shall mandatorily obtain and enter in the scheme data base (a) Aadhaar Number (b) Mobile Number (c) Caste certificate (Mee Seva Certificate only) of all the scheduled Tribe consumers availing the benefit under the scheme by 31st October, 2019.

2. Barring the above, there is no change in the other content of the orders issued in the G.O.Ms.No.94, Social welfare (TW.BUD) Department, Dated 25-07-2019.

3. The Energy & Infrastructure Department/Director of Tribal Welfare, A.P., Vijayawada, shall take necessary action accordingly.
