Further the Chairman has stressed the need to ensure that there is no duplication of works and necessary prioritization is followed while recommending works for sanction. He also observed the following priority areas for further action:

- a) Saturating the requirement of higher education institutions in the tribal areas.
- b) Saturating drinking water requirements and issues concerning operation and maintenance of existing drinking water schemes.
- c) Strengthening staff and infrastructure of agriculture with special reference to the offices of AD, Agriculture in tribal areas.
- d) Road that do not need forest clearance may be taken up in the first phase and action may be initiated for obtaining forest clearance for those works where the clearance is required and they may be taken up in the next phase.
